2013-2014 Annual Student Data Report Highlights

Enrollment

- The total number of full-time students enrolled in the 21 professional O.D. programs in the 50 states and Puerto Rico during academic year 2013-2014 is 6,676, an increase of 1.8% over last year, and an increase of 19.3% since 2008-2009. The number of full-time first-year students increased by 3.3% over last year and increased by 22.3% over the past five years. The percentage of female full-time students in the professional O.D. programs rose to 65.4%, from 64.5% last year; five years ago the percentage was 64.7%. Only one school reported more full-time male students than female students in 2013-2014. (tables 1.1 and 1.2)
- The percentage of Black or African American full-time students rose slightly from 3.0% last year to 3.1% this year; five years ago the percentage was 3.0%. The percentage of full-time Hispanic or Latino students remained steady at 4.5%; five years ago the percentage was also 4.5%. The percentage of full-time Asian students decreased from 29.4% to 28.8%; five years ago the percentage was 26.2%. The percentage of White students decreased slightly from 56.0% to 55.9%; five years ago the percentage was 59.2%. (table 1.3)

- This year, there are 8 part-time students enrolled in the professional O.D. program, up from 7 last year. Five years ago there were 21 part-time students. (table 1.14)
- In 2013-2014, full-time and part-time students come from every state in the U.S. and the District of Columbia, from Puerto Rico and Canada, and from 11+ foreign countries. More students reside in California than any other state, with the next largest group coming from Canada, followed by Texas. (tables 1.17 and 1.19)

Graduates

- The total number of graduates at the schools and colleges of optometry, both regular and special programs, increased 11.6% from 2012 (1404) to 2013 (1567). (table 2.1)
- The number of graduates receiving the O.D. degree through only the regular O.D. program increased 11.7% from 2012 (1,383) to 2013 (1545). (table 2.1)
- In 2013, 63.9% of graduates of the professional O.D. programs, both regular and special programs, were female, down from 64.5% the previous year. In 2013, there were more female graduates than male graduates at 16 out of the 20 schools with a graduating class. (table 2.2)
- The percentage of Black or African American graduates of regular and special programs in 2013 decreased from 2.9% to 2.6%; in 2008 it was 3.4%. The percentage of Hispanic graduates increased from 4.3% to 5.2%; in 2008 it was 4.8%. The percentage of Asian graduates increased from 27.8% to 29.2%; in 2008 it was 22.7%. The percentage of White graduates decreased from 57.3% to 56.3%; in 2008 it was 62.4%. (table 2.3)

Financial Aid/Student Expenses

- In 2012-2013, at least four-fifths of all students at 19 out of 21 optometry schools received financial aid. At 11 of these 21 schools, 90% or more of students received financial aid. Average awards for residents ranged from \$30,625 to \$53,000, and for non-residents from \$30,555 to \$66,307. (table 3.1)
- In 2013-2014, the average tuition for a first-year resident student enrolled in the professional O.D. program was \$20,532 at a public school and \$32,035 at a private school. The cost for all direct expenses (tuition, fees, books and instruments) for a first-year resident student was \$27,867 for a public school and \$37,579 for a private school. First-year non-residents paid an average \$37,644 for tuition and \$44,978 for all direct expenses at a public school, and \$33,149 for tuition and \$38,693 for all direct expenses at a private school.
