2014-2015 Annual Student Data Report Highlights

Updated July, 2015

Enrollment

- The total number of full-time students enrolled in the 21 professional O.D. programs in the 50 states and Puerto Rico during academic year 2014-2015 is 6,797, an increase of 1.8% over last year, and an increase of 16.5% since 2009-2010. The number of full-time first-year students decreased by 1.6% over last year and increased by 6.7% over the past five years. The percentage of female full-time students in the professional O.D. programs rose to 66.1%, from 65.4% last year; five years ago the percentage was 64.0%. Only one school reported more full-time male students than female students in 2014-2015. (tables 1.1 and 1.2)
- The percentage of Black or African American full-time students remained steady at 3.1% from last year to this year; five years ago the percentage was 2.8%. The percentage of full-time Hispanic or Latino students rose from 4.5% to 5.1%; five years ago the percentage was 4.4%. The percentage of full-time Asian students increased from 28.8% to 29.1%; five years ago the percentage was 27.5%. The percentage of White students decreased slightly from 55.9% to 55.8%; five years ago the percentage was 57.3%. (table 1.3)
- There are 8 part-time students enrolled in the professional O.D. program, the same as last year. Five years ago there were 15 part-time students. (table 1.14)
- In 2014-2015, full-time and part-time students come from every state in the U.S. and the District of Columbia, from Puerto Rico and Canada, and from 11+ foreign countries. More students reside in California than any other state, with the next largest group coming from Texas, followed by Canada. (tables 1.17 and 1.19)

Graduates

- The total number of graduates at the schools and colleges of optometry, both regular and special programs, increased 0.1% from 2013 (1567) to 2014 (1569). (table 2.1)
- The number of graduates receiving the O.D. degree through only the regular O.D. program decreased 0.3% from 2013 (1,545) to 2014 (1541). (table 2.1)
- In 2014, 64.6% of graduates of the professional O.D. programs, both regular and special programs, were female, up from 63.9% the previous year. In 2014, there were more female graduates than male graduates at 17 out of the 20 schools with a graduating class. (table 2.2)
- The percentage of Black or African American graduates of regular and special programs in 2014 decreased from 2.6% to 2.4%; in 2009 it was 2.7%. The percentage of Hispanic graduates decreased from 5.2% to 3.4%; in 2009 it was 4.9%. The percentage of Asian graduates increased from 29.2% to 30.1%; in 2009 it was 23.0%. The percentage of White graduates decreased from 56.3% to 56.1%; in 2009 it was 63.2%. (table 2.3)

Financial Aid/Student Expenses

- In 2013-2014, at least four-fifths of all students at 19 out of 21 optometry schools received financial aid. At 8 of these 21 schools, 90% or more of students received financial aid. Average awards for residents ranged from \$29,708 to \$55,392, and for non-residents from \$35,259 to \$72,877. (table 3.1)
- In 2014-2015, the average tuition for a first-year resident student enrolled in the professional O.D. program was \$21,489 at a public school and \$33,014 at a private school. The average cost for all direct expenses (tuition, fees, books and instruments) for a first-year resident student was \$28,854 for a public school and \$38,429 for a private school. First-year non-residents paid an average \$39,741 for tuition and \$47,107 for all direct expenses at a public school, and \$34,271 for tuition and \$39,686 for all direct expenses at a private school. (tables 3.5 and 3.7)
