2023-2024 Annual Student Data Report

Highlights

ASCO's 2023-2024 Annual Student Survey opened for completion on October 5, 2023, with a requested completion date of November 8, 2023. Data was collected from all 24 U.S. professional O.D. programs with enrolled students as of fall 2023.

Enrollment

- The number of full-time students as of fall 2023 was 7220, an increase of 0.2% from last year and 0.6% over 2018-2019 figures. The number of full-time first-year students increased 4.9% from last year and 5.2% since 2018-2019. The percentage of female full-time students in the full-time professional O.D. programs moved very slightly from 70.5% to 70.6%; five years ago the percentage was 68.2%. Every school reported more full-time female students than male students in 2023-2024. (tables 1.1 and 1.2) There were an additional 164 students enrolled in part-time, alternate and special programs leading to the O.D. degree, down from 173 last year. (table 1.16)
- The percentage of full-time Black or African American students remained at 4.3% from last year; five years ago the percentage was 2.7%. The percentage of full-time Hispanic or Latino students increased to 8.8% from 8.7%; five years ago the percentage was 6.6%. The percentage of full-time Asian students increased to 31.3% from 30.4%; five years ago the percentage was 30.3%. The percentage of White students decreased to 48.5% from 49.5%; five years ago the percentage was 51.4%. The percentage of students classified as two or more races rose to 3.4% from 2.9% last year; five years ago it was 2.0%. (table 1.3)
- There were 39 part-time students enrolled in the professional O.D. program; last year there were 54 and five years ago there were 15. (table 1.14)
- In 2023-2024, full-time and part-time students came from every state in the U.S. and from the District of Columbia and Puerto Rico, from Canada and from 22 other foreign countries. More students resided in California than any other state, with the next largest group coming from Texas, followed by Canada. (tables 1.18 and 1.20)

Graduates

- The total number of graduates at the schools and colleges of optometry, from both regular and special programs, increased 5.7% from 2022 to 2023, rising from 1728 to 1827, with 23 schools awarding degrees. The number of graduates from regular and special programs has increased 9.6% since 2018, when there were 21 schools awarding degrees. (table 2.1)
- The number of graduates receiving the O.D. degree through only the regular O.D. program increased 5.4% from 2022 to 2023, moving from 1700 to 1791. The number of graduates from regular O.D. programs has increased 9.2% since 2018. (table 2.1)
- In 2023, 71.2% of graduates of the professional O.D. programs, both regular and special programs, were female, up from 67.8% the previous year. In 2018, 67.9% of graduates were female. In 2023, there were more female graduates than male graduates at all 23 schools. (table 2.2)
- The percentage of Black or African American graduates of regular and special programs increased from 2.5% in 2022 to 4.0% in 2023; in 2018 it was 2.9%. The percentage of Hispanic graduates rose from 5.7% to 8.1%; in 2018 it was 5.1%. The percentage of Asian graduates increased from 30.4% to 30.7%; in 2018 it was 30.4%. The percentage of White graduates decreased from 53.5% to 50.2%; in 2018 it was 55.3%. The percentage of graduates classified as two or more races decreased from 3.2% to 2.5%. In 2018 it was 2.0%. (table 2.3)
- The permanent residence of graduates remained almost unchanged from last year, with 92.2% of graduates of both regular and special O.D. programs with a permanent residence in the U.S. or in U.S. territories, 6.8% in Canada and 0.9% in other countries. In 2018 the figures were 91.8%, 7.5% and 0.7%. (table 2.4)

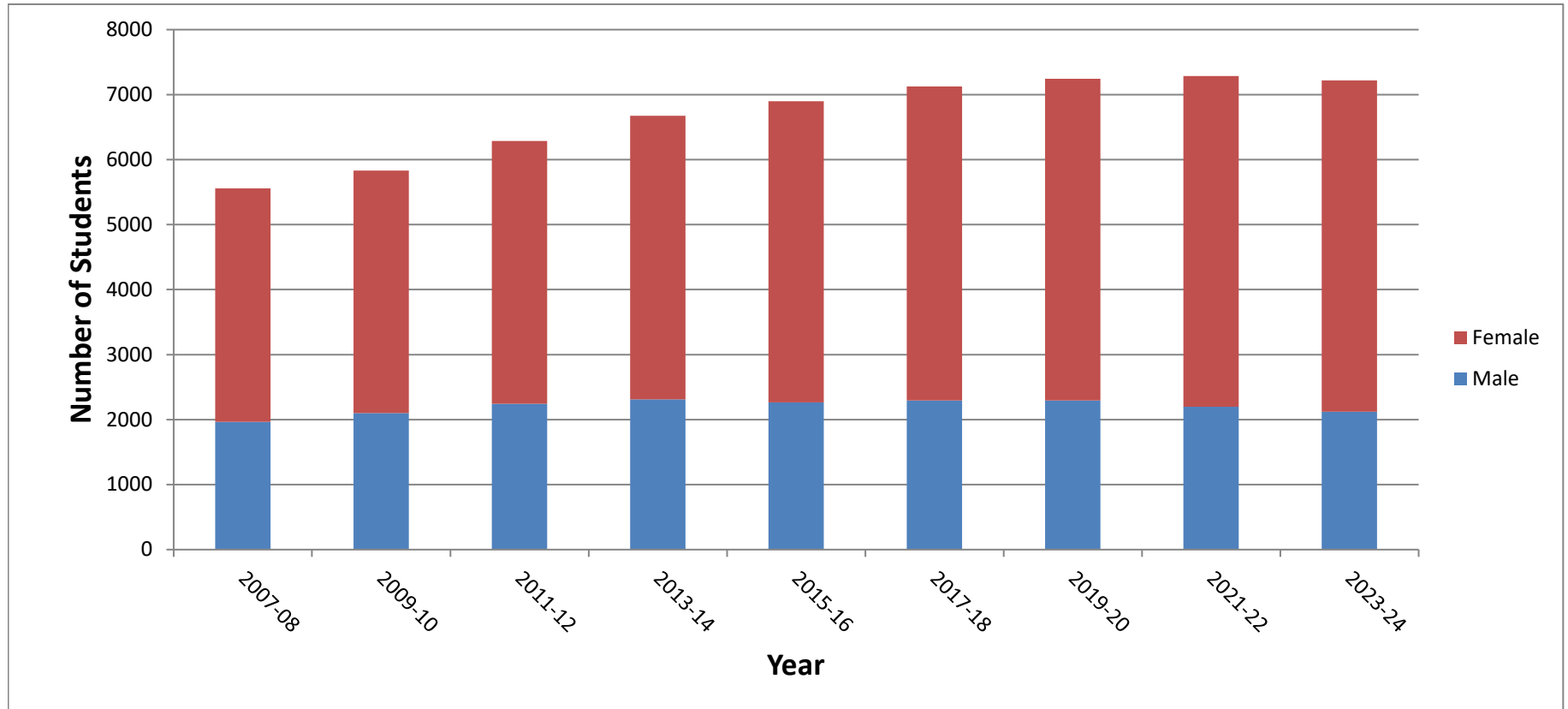
Financial Aid/Student Expenses

- In 2022-2023, the percentage of students receiving financial aid was 87.8%, up from 85.4% the previous year. The average award in 2022-2023 was \$54,446, up from \$53,755 in 2021-2022. (table 3.1)
- In 2023-2024, the average tuition for a first-year resident student enrolled in the professional O.D. program was \$29,520 at a public school and \$44,653 at a private school. The average cost for all direct expenses (tuition, fees, books and instruments) for a first-year resident student was \$37,703 for a public school and \$50,041 for a private school. First-year non-residents paid an average \$46,169 for tuition and \$54,352 for all direct expenses at a public school, and \$44,653 for tuition and \$50,041 for all direct expenses at a private school. (tables 3.5 and 3.7).

(Regular Programs)



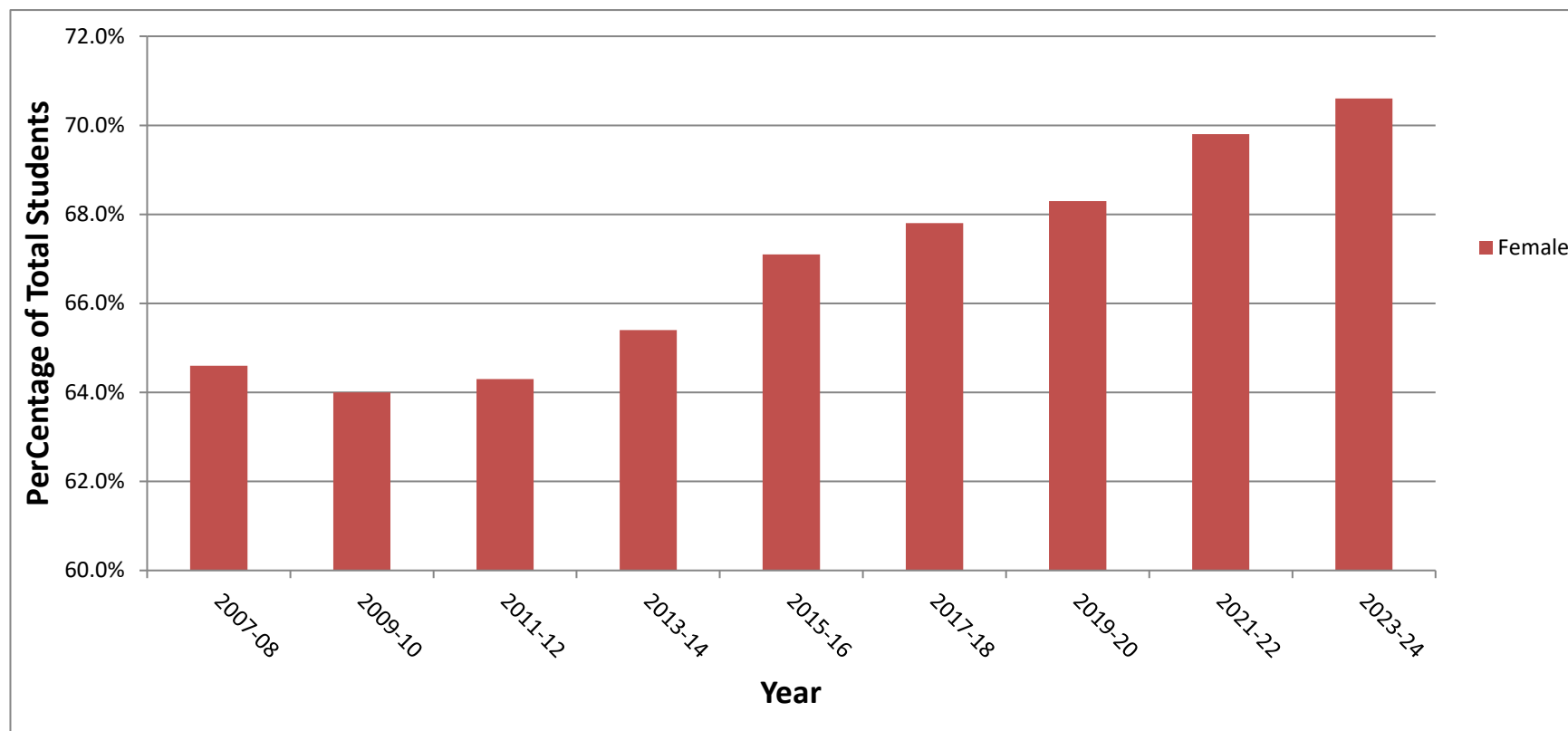

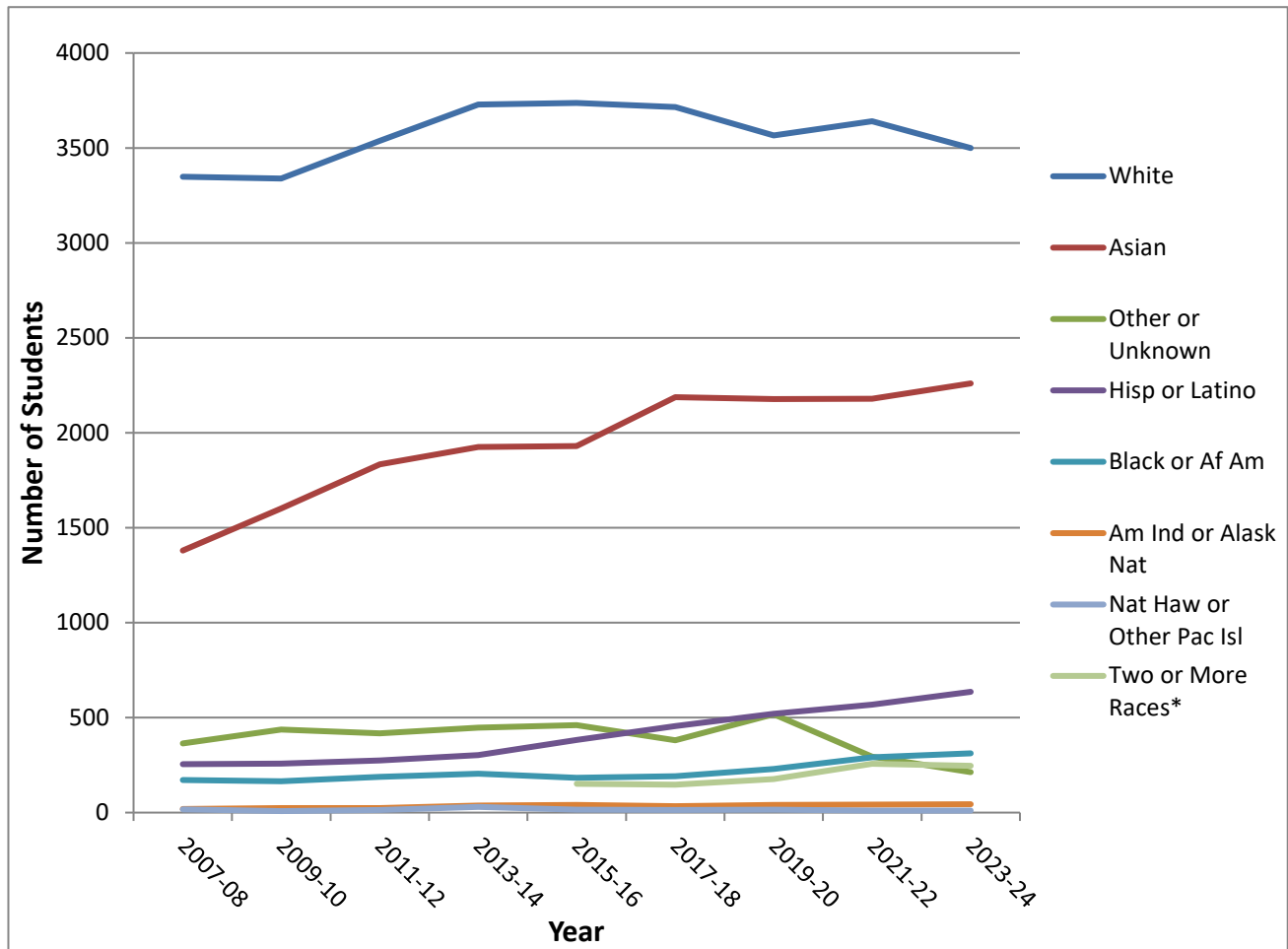

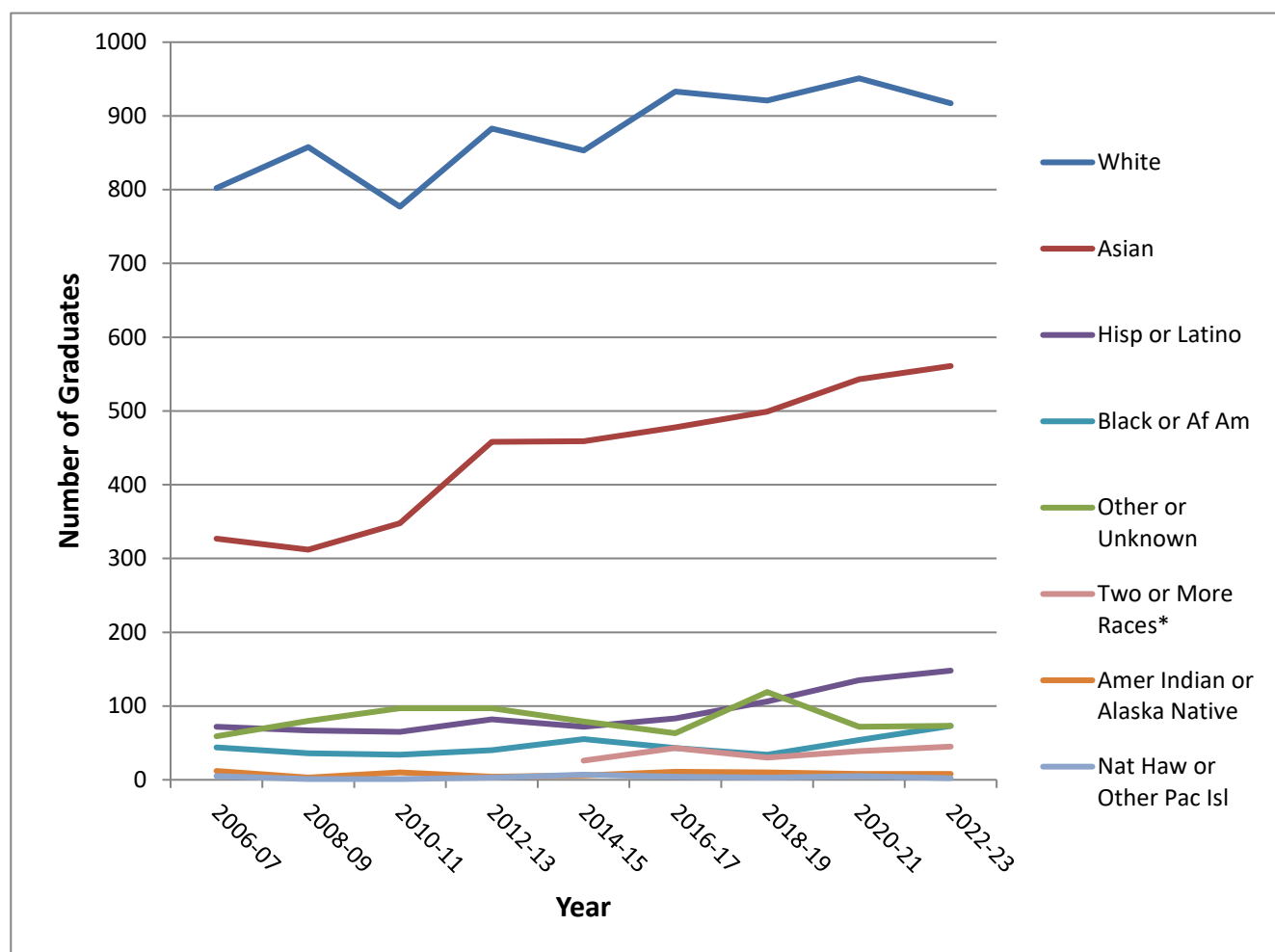

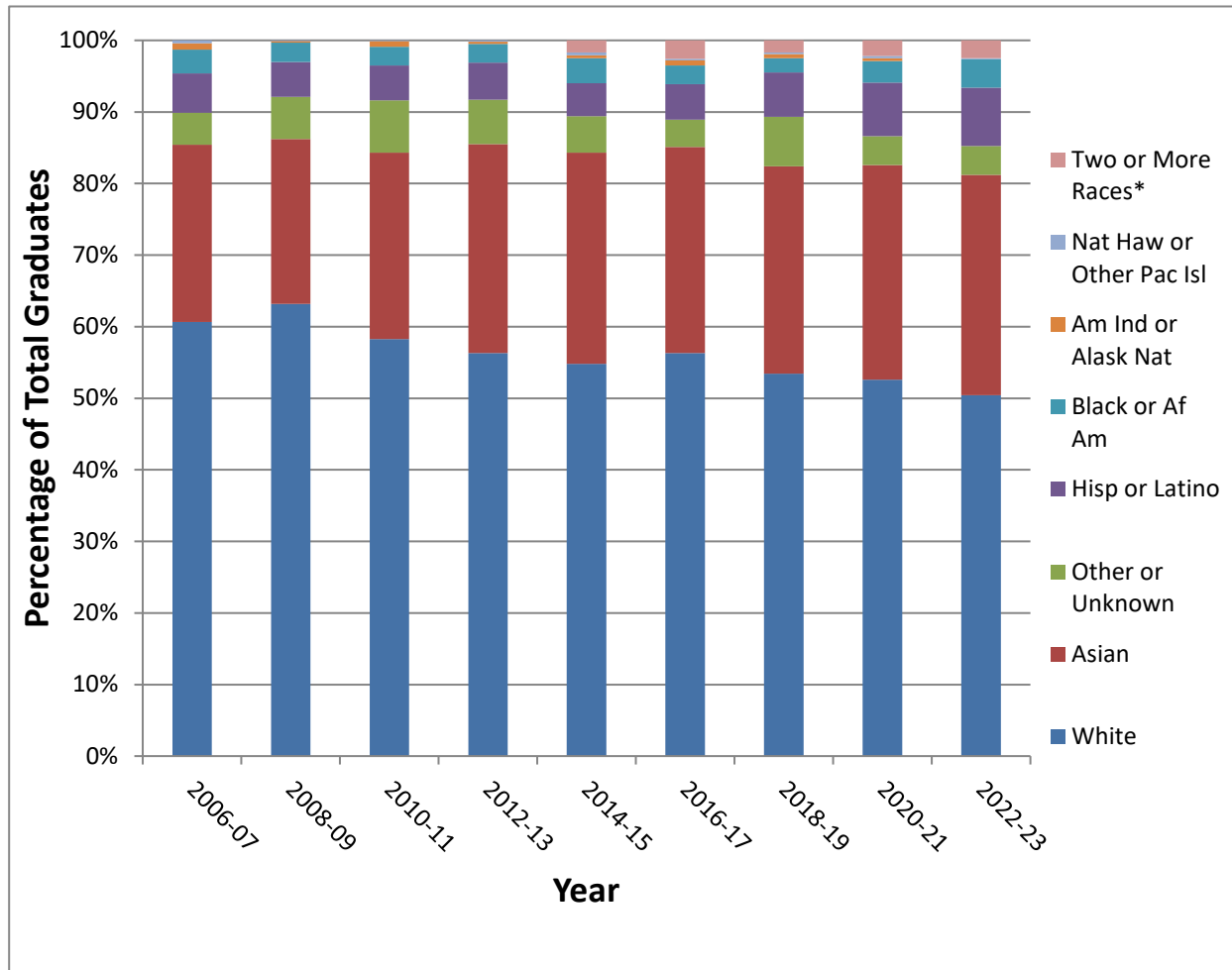

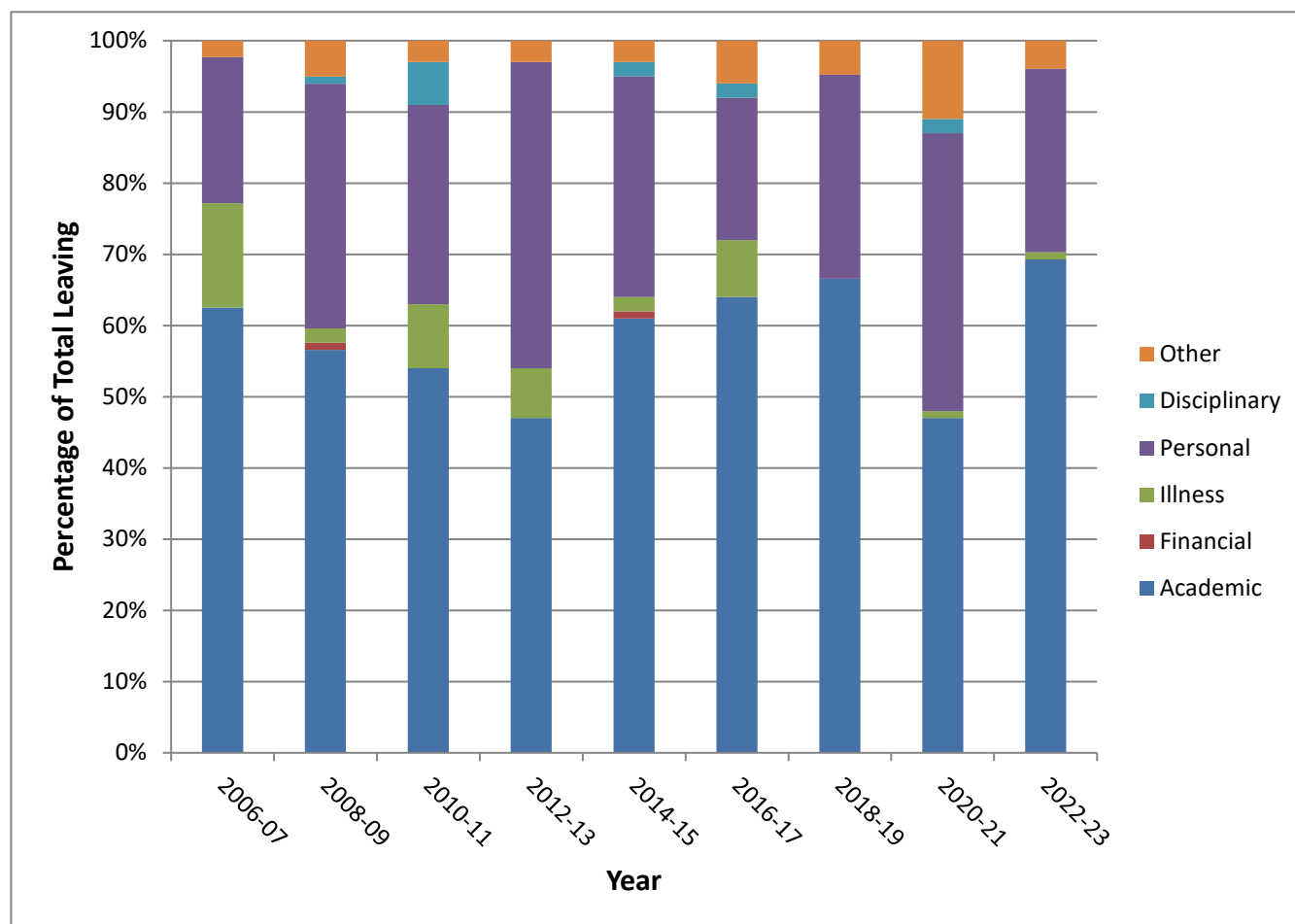

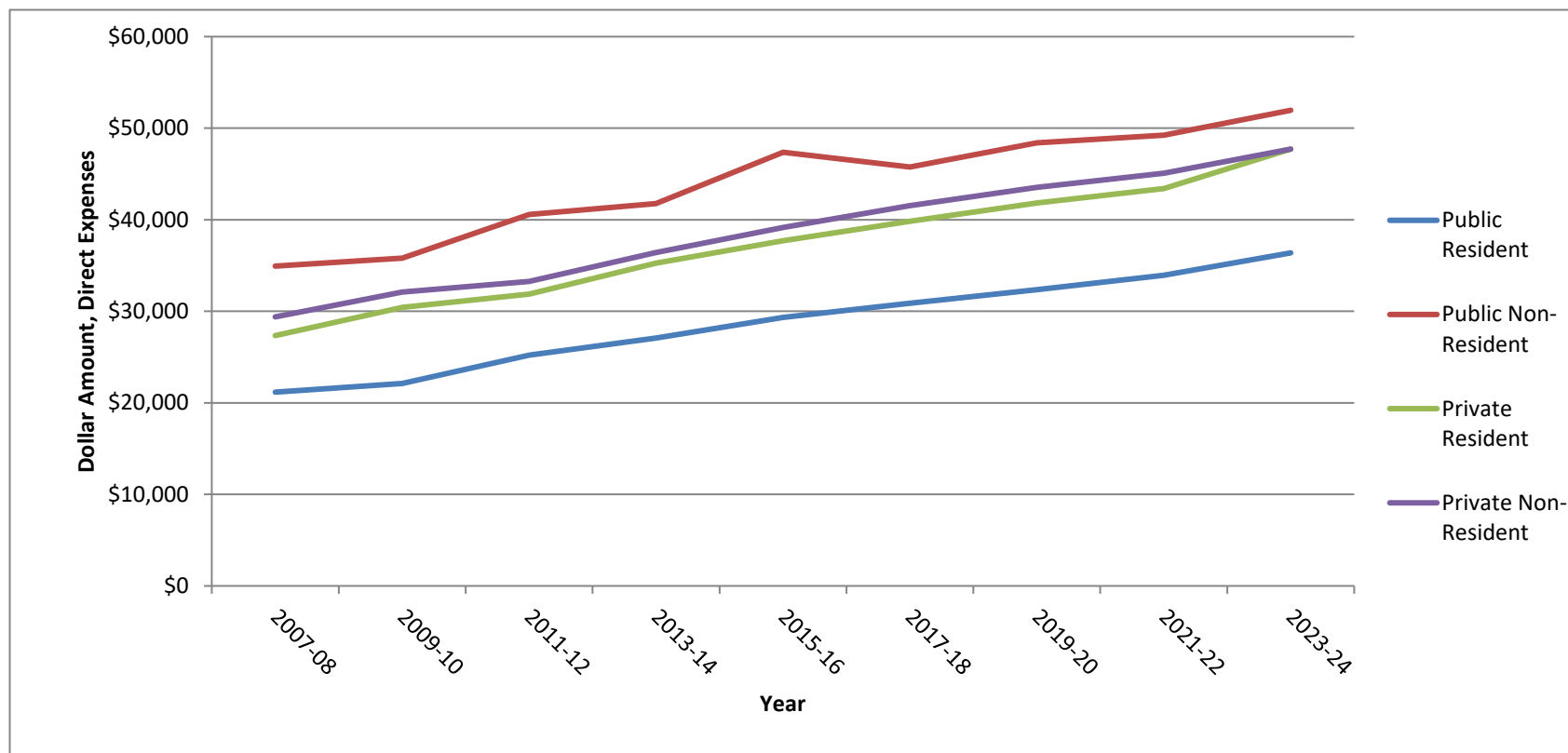

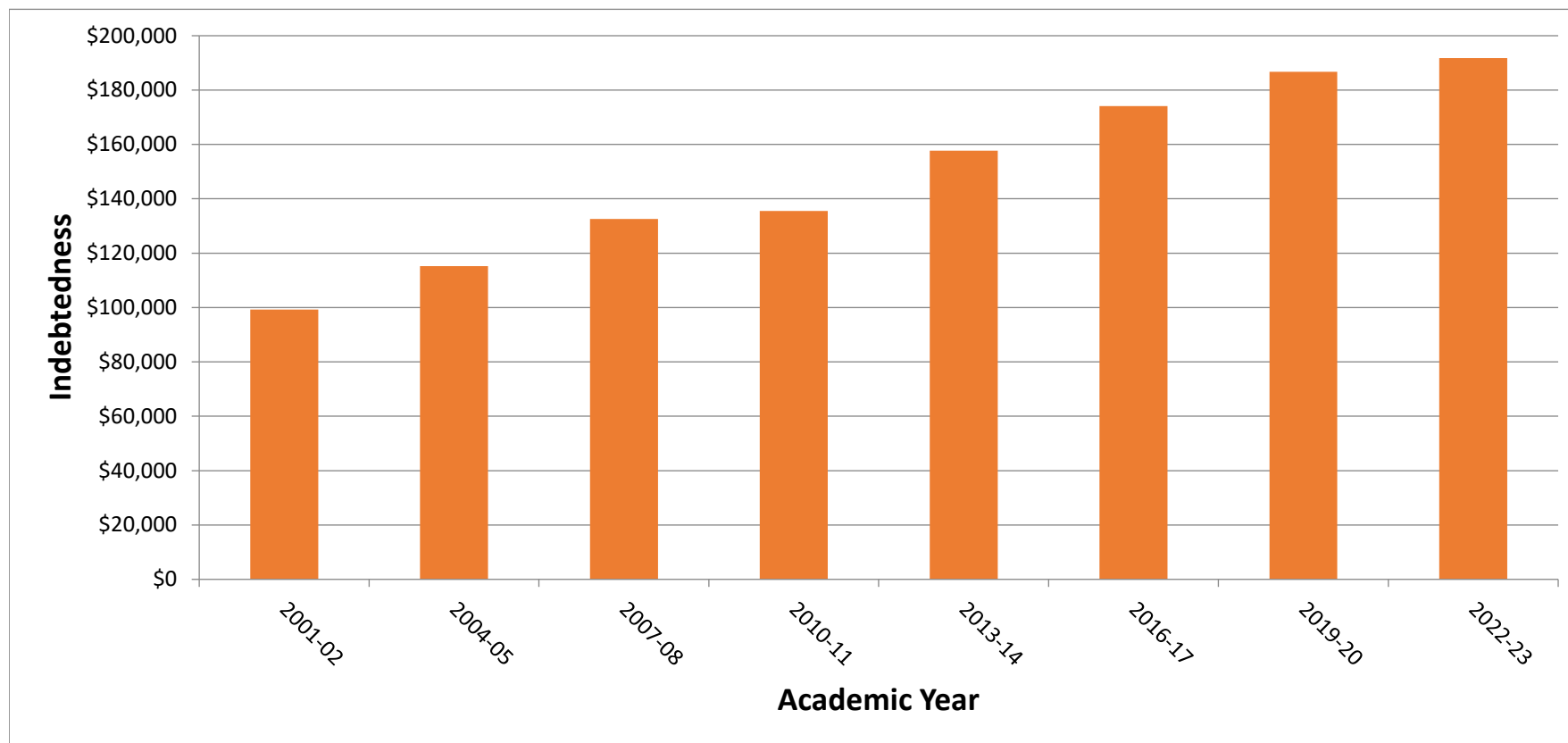

Alternate and Special Programs for the O.D. Degree, AY 2023-2024

	Descriptions of all special or alternative programs leading to the OD degree:
IUSO	The Indiana University School of Optometry offers Advanced Placement into the OD program for individuals who have graduated from an accredited international optometry program, or who have graduated with an international medical degree. This program allows candidates to earn a Doctor of Optometry by giving them the opportunity to test out of didactic and clinical courses. Each applicant is assessed on an individual basis and an individual study plan will be created based on each applicant's experience and test results. Successful applicants could complete the 4-year degree in as little as 3 years.
NECO	Accelerated Optometric Degree Program The Accelerated Optometric Degree Program, AODP, is an accelerated program for scientists and physicians who hold a doctoral degree in science or medicine (or equivalent experience). Applicants demonstrate high scholarship in previous graduate study, as well as a firm career commitment to optometry. The program was established in 1972 to attract highly qualified candidates who can provide unique contributions to the profession of optometry through teaching, research and clinical care. This program is designed to provide an accelerated education for qualified applicants with either an earned doctorate in one of the biological, behavioral, or physical sciences; or a doctoral-level health profession degree. Once admitted, AODP students follow an intense thirty-six month curriculum, which includes a full year of clinical rotations, engaging in full time patient care. Upon completion, graduates of the program are prepared to enter the profession in clinical practice, optometric education, or research. Advanced Standing International Program Through the College's Advanced Standing International Program (ASIP), graduates of international optometry programs may be admitted with advanced standing to the doctor of optometry degree program. ASIP students have to meet the same standards as the other program students, and reach the same competency standards in clinics in order to receive the Doctor of Optometry degree. Once admitted, ASIP students follow an intense two year curriculum, which includes one year of clinical externship rotations. Course work centers on basic sciences, disease, and advanced optometry skills and concepts. MS/OD China The MS/OD China Program is a unique joint degree program between Wenzhou Medical University (WMU) and the New England College of Optometry (NECO). Students who complete the program earn two degrees: the master of science and doctor of optometry degrees. The MS/OD China curriculum combines the AODP curriculum and the Master of Science degree with joint clinical externships that include six months in Boston-based rotations and six months at Wenzhou Medical University.
NOVA	The extended 5-year program is for students that need a lighter course load for reasons such as being out of school for several years or family obligations. The first 2 years of the traditional program are extended to 3 years. The final 2 years of the traditional and extended programs are identical. Graduates of foreign schools are considered by the Committee on Admissions and the Transfer Committee for possible enrollment into a 3-year program on a case by case basis.

Descriptions of all special or alternative programs leading to the OD degree:	
PCO/Salus	The Advanced Placement Doctor of Optometry degree (APOD) program offers an additional pathway to the OD degree specifically for interested and qualified international practitioners. Eligible applicants will be given a customized course of study that is designed based upon the applicant's previous education and clinical experience as well as their career goals. The Accelerated Scholars Program at Salus University Pennsylvania College of Optometry (PCO) is an opportunity for highly motivated and well-qualified applicants to earn a Doctor of Optometry degree designed specifically with them in mind. This program provides students with the opportunity to complete all the same traditional program optometry degree requirements in an accredited 36-month, year-round, campus-based program.
